5. Rules

- 5.1 Rules of weigh-in Service charge for changing of weight classes: EUR 20.00
- 5.2 Identification According to the Rules of the German Taekwondo Federation, all competitors need to have a valid passport.
- 5.3 Declaration of consent All competitors who are not 18 years and older at the day of the tournament need a declaration of consent by a legal guardian which must be presented at the weigh-in.
- 5.4 Liability Only members of national federation's affiliation with the ETU are allowed to compete. For countries without any federation being member of the ETU, affiliation with WTF is necessary. Upon registration, the contestants must prove their memberships by means of a valid license. Exceptions of this rule can be requested at the control board of the North-Rhine Westphalia Taekwondo Union. All competitors of the International Masters NRW participate at their own risk. The registration application implies that the contestants agree to assume all responsibility for themselves and to release all others from all and any liability which may directly or indirectly result from the International Masters NRW. All contestants must bring their own documents and forms for any medical treatment in Germany.
- 5.5 Protest Only the official coach is a allowed to protest, immediately after the end of the contest. An amount of € 100,00 Euro, will have to be paid for each protest and will be returned if the protest was found valid. The decision of the board is final.
