By registering / authorizing for the International West German Championships the participant / club agrees to pay the entry fee for all registered competitors. Payment must be received within the registration deadlines mentioned above and no later than two weeks after registration. Competitors who are not withdrawn before the deadline will be charged to their respective club.

No refunds will be made after the regular deadline or for no shows. Please ensure that the entry fees are received in the bank account mentioned above no later than September 11th, 2026. Cash payments on the competition day are not possible!

Participation requirements

Eligible to participate are **all members of the DTU/ ETU/ WT**. By submitting an online registration for the tournament, the registering club confirms the active membership of all registered participants in the DTU/ ETU/ WT. Proof of membership must be provided by means of a valid DTU membership booklet, valid GAL Card, or a valid national Taekwondo identification document. **All** participants must submit a signed declaration of consent during registration. For minors, a declaration of consent signed by a parent or legal guardian is required, confirming their agreement to the participant's involvement in the event and their acceptance of all provisions of this outline and regulations.

Each participant takes part in this tournament on their own responsibility and under these conditions. Age verification must be provided at the weigh-in by presenting an original valid government-issued photo identification document. Copies, faxes, or screenshots will not be accepted!

By registering, clubs, athletes, and legal guardians acknowledge and accept all provisions of this outline and regulations. Athletes confirm that they are in good physical and medical condition to participate in the event. Participants are required to carry their health insurance card. Registrations that are not submitted online, for which the registration fees have not been paid, or that are received after the registration deadline will not be accepted. If an athlete or team fails to appear, the registration fee will not be refunded. The same applies if athletes are not permitted to compete due to failure to meet the participation requirements.

Responsible coaches or team officials must inform the Competition Management in a timely manner before the start of the competition of any withdrawals or cancellations (e.g. due to illness).

Competition equipment

According to the rules and regulations of the German Taekwondo Union. Electronic protector and scoring system by Daedo (Gen. 3) will be used. Electronic foot protectors may be borrowed from the organizer on a match-by-match basis upon deposit of collateral (smartphone). Participants may use electronic sensor gloves; however, these will not be provided by the organizer. Electronic foot protectors will be available for purchase on site for 75 €. Sensor gloves will be available for purchase for 40 € per pair. Both items can also be purchased in advance via www.daedo-gen3.de or www.hattinger-kampfsport-shop.com.



Rules and regulations

- Rules:** The currently valid competition rules (WOZ) of the German Taekwondo Union (DTU) apply. Deviations or special rules regarding these competition rules require approval by the protest committee at the competition day.
- Competition method:** Single elimination, KO-System (Best of three)
- Eligibility:** All participants must be affiliated members of DTU, ETU or WT.
- Duration of contests:** Maybe shortened depending on the number of participants.
- Team ranking:** Based on individual results, ranking is determined according to the medals table:

If two teams (or more) achieve the same overall result, team ranking will be decided by the number of medals won, excluding those awarded without a contest, and second by the number of participants. In this case the team with fewer participating athletes will be ranked higher. The third criterion is the number of matches won in the higher weight classes.
- Awards:** Medals for places 1 - 3 Individual awards
Trophies for places 1 - 5 Team awards
- Result publication:** By submitting a registration, participants consent to the publication of their surname, first name, club affiliation, weight category, nationality, and final

Protest:

Only an officially registered coach is allowed to protest immediately after the end of the contest. A protest fee needs to be paid for each protest immediately. The decision of protest committee chairman is final. (DTU- WOZ, Art. 19.1).

For a certain number of athletes above mentioned coaches have free admission, but at maximum 6 coaches per club. The minimum age for a coach is 17 years and must wear a training suit with indoor shoes (light soles). A towel is required.

Declaration of consent

All participants must submit a signed declaration of consent on the day of the tournament. Minors (under 18 years of age) must provide a declaration of consent signed by a parent or legal guardian. The declaration of consent forms must be printed and brought to the tournament. Entries or signatures in the DTU membership booklet will not be accepted. Consent forms can be submitted prior to the tournament digitally at latest by **Thursday, 11.09.2026 (11:59 PM)** exclusively on a club-by-club basis and as a single consolidated PDF file, to n.kazkaz@nwtu.de.

Liability declaration

Every person participates at their own risk. With the registration, each contestant or their legal guardian agrees explicitly to the exclusion of liability. Promoter and organizer do not assume liability for any damage to persons or property!

Data protection notice

By registering, the athlete consents to the storage, processing, and use of their personal data as far as necessary for the execution of the sports event and federation purposes.

Anti-Doping

All participants explicitly acknowledge the current National Anti-Doping Code (NADC21) and agree to its application by registering and participating in the tournament.
